## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AIRCODE USA, INC.

Pursuant to the provisions of Section 607.1006, F.S., AIRCODE USA, INC., hereby adopts the following amendment to its Articles of Incorporation.

- 1. Name of Corporation: AIRCODE USA, INC.
- 2. Document Number: The document number of the Corporation is P06000131505.
- Amendment Adopted: Article IV of the Articles of Incorporation is hereby amended to read as follows:

## "ARTICLE IV - Capital Stock

The corporation is authorized to issue 60,000,000 shares of common, voting shares, which shall be designated as "Common Voting Shares." The par value of each share of Common Voting Shares shall be \$0.0001. The corporation is authorized to issue 60,000,000 shares of common, non-voting shares, which shall be designated as "Common Non-Voting Shares." The par value of each share of Common Non-Voting Shares shall be \$0.0001

Director Approval: The amendment was adopted by the board of directors without shareholder action as shareholder action was not required.

The above amendment was adopted on the 17th of May, 2010.

5. Other Amendments: All other articles and provisions of the Articles of Incorporation as originally filed remain the same.
