The Amended Articles were adopted by a majority of the Corporation's Directors and Shareholders on the 22 day of October, 2012.

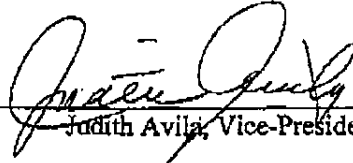

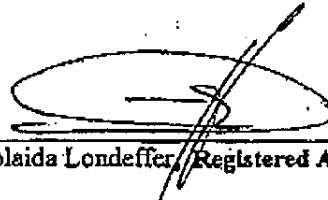
