Capital Stock

#### **ARTICLE X**


Amendment to Articles



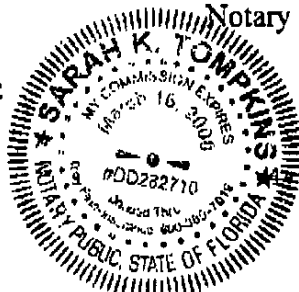
