AMENDMENT

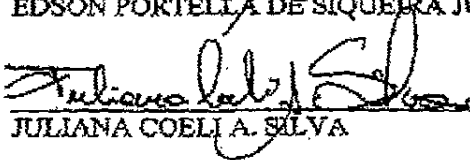

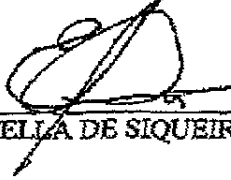
