The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I - NAME OF CORPORATION**

The name of this Corporation shall be Seralago Acquisitions, Inc.

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office of this Corporation shall be located at 541 N. Palmetto Avenue, Suite 150, Sanford, Florida 32771, which shall also be the mailing address of the Corporation.

**ARTICLE III - CAPITAL STOCK**
