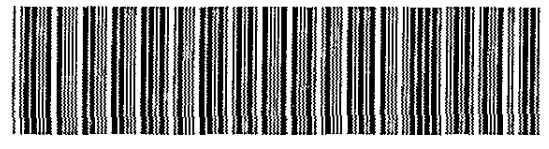

Articles of Incorporation

The undersigned Incorporator hereby make, subscribe to, acknowledge and file these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit under the Laws of the State of Florida.

Article I

The name of the Corporation shall be:

And it shall be herein referred to as the corporation.

Article II

The address of the principal office of Ron's Finishes, Inc. shall be 1470 Pell Road, Osteen , FL 32764.

Article III

The general purpose for which the Corporation is initially organized is to provide the full range of Home Repair Services.
