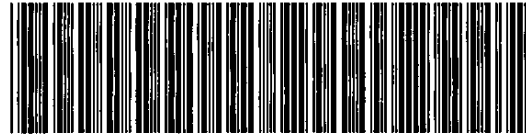

Corporation existence is to begin on the date that these Articles of Incorporation are executed and acknowledged.





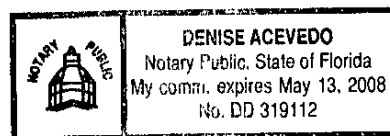
