

Article – Fourteen



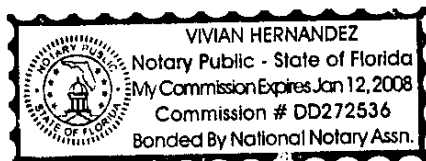
