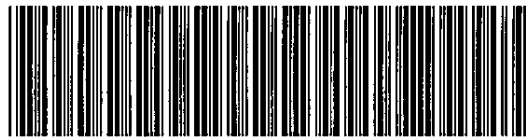

NAME**

The name of this Corporation is ALERT ALUMINUM, INC.

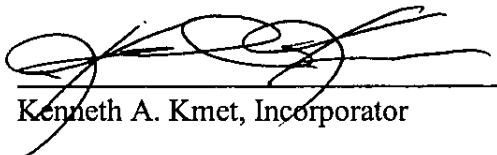
**ARTICLE IX

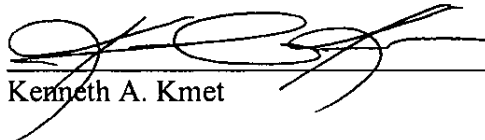
