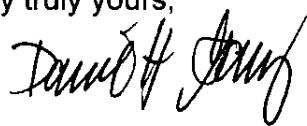

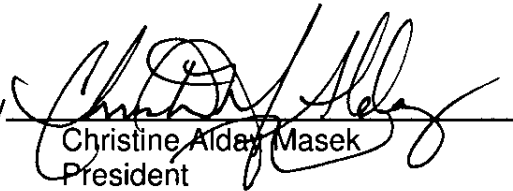
6. All liabilities and obligations of the Corporation have been paid or discharged, or adequate provision has been made therefor.

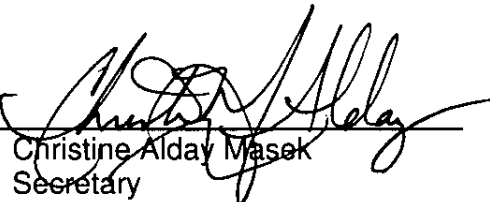

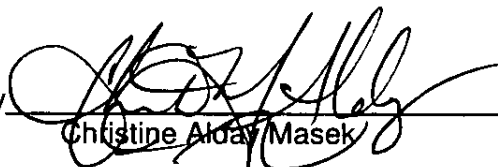

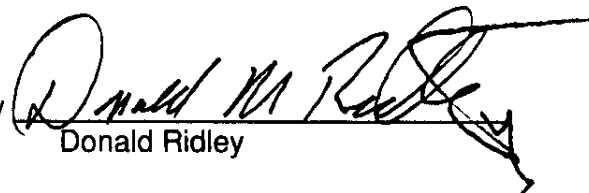
