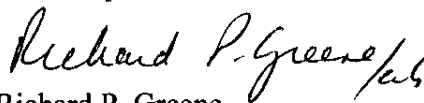

**ARTICLES OF INCORPORATION
OF
WELLCINE CORPORATION**

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 689 and/or Chapter 621, Florida Statutes, does hereby adopt the following Articles of Incorporation:

WITNESSETH:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

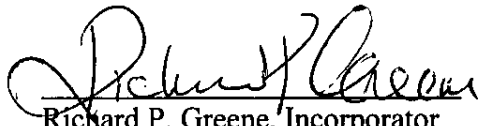
ARTICLE IX

LIMITATION ON SHAREHOLDER SUITS

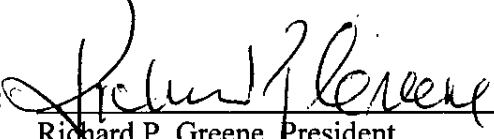
