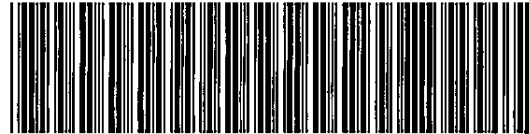

OF

Article I: The name of the corporation is: M & O Restaurants, Inc.


Article VIII: The duration of the corporation is perpetual.
