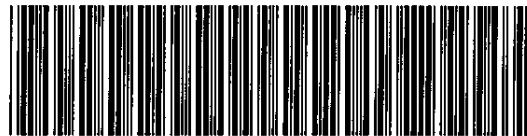

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopts the following articles of incorporation:

ARTICLE I
NAME AND PRINCIPAL OFFICE ADDRESS

The name of the corporation shall be APACHE SKUNK WERKS, INC. , and the principal office and mailing address is: 4520 Bruton Road, Plant City, FL 33565 .

ARTICLE II
DURATION

The term of existence of the corporation shall be perpetual.

ARTICLE III

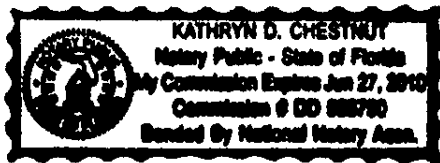
