ARTICLES OF INCORPORATION OF BOGARTZ CIGAR LOUNGE, INC.



ARTICLE I - NAME

The name of this corporation is BOGARTZ CIGAR LOUNGE, INC. The principal address of said corporation is 8600 SE 7th Avenue Road, Ocala, Florida 34480.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

- 4.1 This corporation is authorized to issue 7,500 shares of \$1.00 par value common stock.
- 4.2 Stock Certificates. Certificates of stock shall be signed by the president or the vice president, joint with the secretary and the seal of the corporation shall be impressed thereon.
- 4.3 Shares Not in Classes. The shares of the corporation are not to be divided into classes.

presence and participation of such interested persons at the meeting of the board of the corporation that acts upon, or in reference to the contract or transaction; provided, the interested party does not vote or participate in the action; that the interested party discloses his interest before action is taken, and the contract or transaction is fair and reasonable as to the corporation at the time it is authorized by the board or its shareholders. This Section is intended to expand the ability of the corporation to conduct business with interested parties and shall not be construed to invalidate any contract of other transaction that would otherwise be valid under the common and statutory law applicable to it.

ARTICLE VIII - INITIAL REGISTERED AGENT AND OFFICE

The name of the initial registered agent of this corporation is CHESTER J. TROW, who has signed a Certificate of Acceptance attached to these Articles of Incorporation to indicate his acceptance, which Certificate is incorporated herein by reference.
