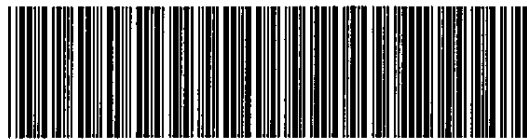



ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **FLOORFX, INC.** and its principal place of business shall be located at **4301 THORNHILL ROAD, WINTER HAVEN, FL 33880.**

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.
