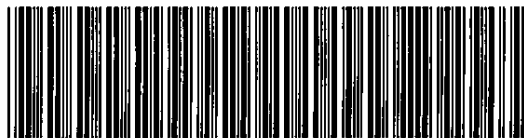

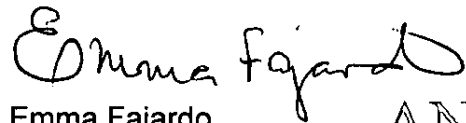

**ARTICLE I**  
**CORPORATE NAME**
