#### ARTICLES OF INCORPORATION

OF

#### MSK TELERADIOLOGY, INC.

The undersigned incorporator, for the purpose of forming a corporation in the state of Florida hereby adopts the following Articles of Incorporation.

# Article I Name and Duration

The name of this corporation is MSK Teleradiology, Inc. The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

# Article II Principal Office

The address of the principal office and mailing address of the corporation in the State of Florida is 1991 Mipaula Court, Atlantic Beach, Florida 32233.

# Article III Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one hundred (100) shares having no par value.

## Article IV Registered Office and Agent

#### Article V Directors

1. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.
