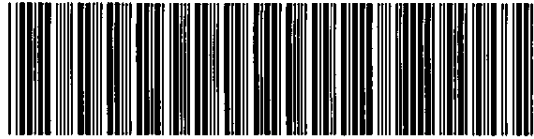

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is COMMERCIAL REAL ESTATE CONNECTIONS, P.A., a Florida corporation, and the principal office is located at 189 Albert Lane, Port Charlotte, Florida 33954.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

This corporation shall exist perpetually.

ARTICLE 3. - PURPOSES

The nature of the business and the objects and purposes for which the corporation is formed and which may be transacted, promoted and carried on by the corporation are to be a provider of real estate services of every nature and description and to conduct any and all other business permitted under the laws of the State of Florida.



ARTICLE 9. - AMENDMENT




