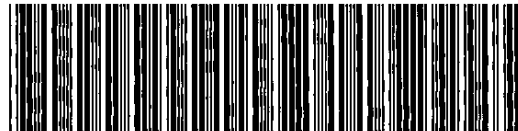

than one.


