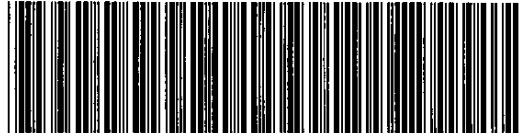

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, Florida Statutes.

ARTICLE I

The name of the corporation is "Floridians for Real Family Values, Inc." The principal place of business is: 401 E. Las Olas Blvd., Suite 130-104, Fort Lauderdale, Florida 33301.

ARTICLE II

This corporation shall have perpetual existence.

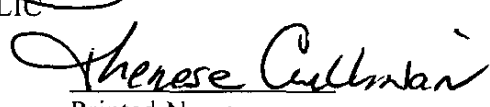

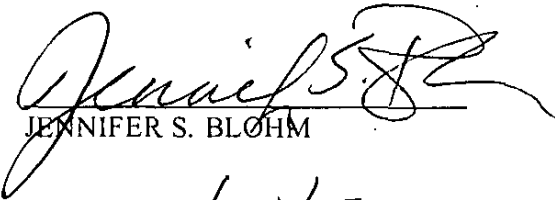
