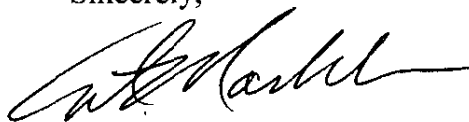

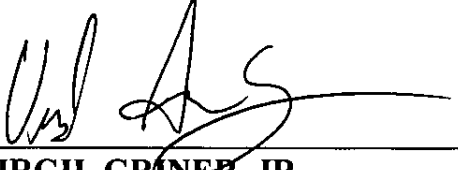
IV. All liabilities and obligations of the corporation have been paid or discharged.

day of September, 2007.

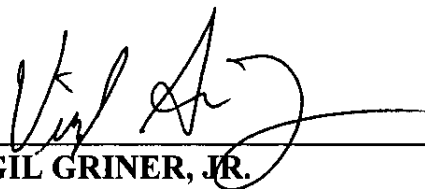
