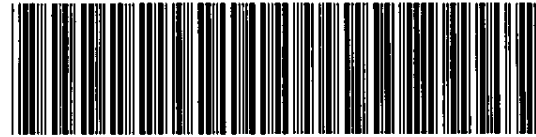

ARTICLE I.

NAME

The name of this corporation is Alstott Travel, Inc.

ARTICLE II.

PRINCIPAL OFFICE

ARTICLE III.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of October 20, 2006.

ARTICLE IV.

AMENDMENT


