The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Brevard Cardiovascular Research Associates, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 465 Lanternback Island Drive, Satellite Beach, Florida 32937. The mailing address of the Corporation shall be P. O. Box 542262, Merritt Island, Florida 32954-2262.

ARTICLE III - CAPITAL STOCK


ARTICLE VIII - INDEMNIFICATION

ARTICLE IX - DATE OF EXISTENCE


This Corporation shall exist perpetually, commencing on the date of filing of these Articles of Incorporation.
