ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is KARINA AUTO SALES, INC., whose address is: 2200 Highway 92 East, Lakeland, Florida 33801.

ARTICLE II - PURPOSE


