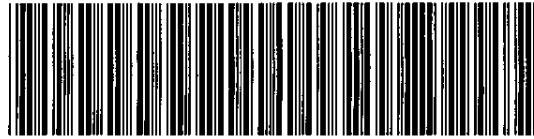

**ARTICLE I.**

The name of this corporation is **SUNSHINE BRIGHT SERVICES, INC.**

**ARTICLE II.**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III.**

This corporation is organized for the purpose of transacting any or all lawful business as a Janitorial and Carpentry Services.
