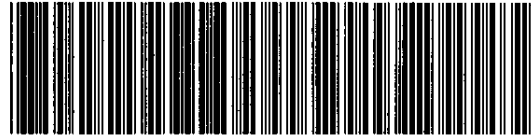

Dissolution of the corporation was approved and authorized on September 22, 2010.




