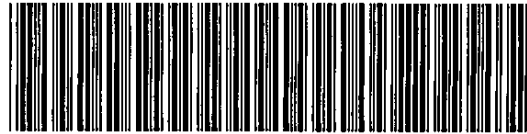

Residential Cleaning Services

Residential Cleaning Services will be provided to homes, condos, apartment buildings, new houses, vacation rentals, resorts, apartment punch out and cleaning. under residential cleaning services, Charlie's Angels will provide cleaning services in the following capacity

- All Rooms, Clean / mop tile, linoleum, and wood flooring
Dust / clean furniture, shelves, pictures, Dust / clean woodwork and window sills, Clean glass fixtures - within reach, Vacuum furniture, floors and stairways, Remove cobwebs.
