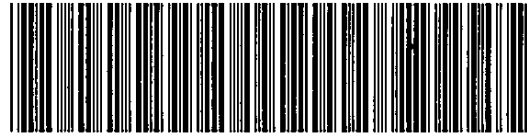

**ARTICLE I - NAME**

The name of this corporation is Wenter Corporation.

**ARTICLE II - DURATION**

This corporation shall exist perpetually.

**ARTICLE III - PURPOSE**
