## ARTICLE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FLORIDA COAST BANK

Pursuant to the provisions of Sections 607.1005, 607.1006, and 658.23 Florida Statutes, Florida Coast Bank (the "Bank") hereby adopts the following Article of Amendment to the Bank's Articles of Incorporation, filed on November 1, 2006.

The proposed amendment will replace Article I of the Articles of Incorporation in its entirety, and the full text of the new Article I will read as follows:
