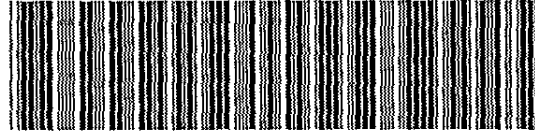

ARTICLE I

NAME






