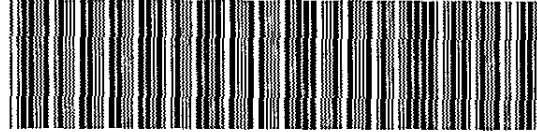

NAME




