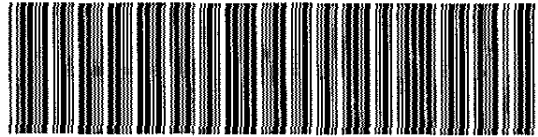

The undersigned acting as incorporator of Amulet Investors I, Inc. desiring to form a corporation under the Florida Business Corporation Act, Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Amulet Investors I, Inc. (the "Corporation").

ARTICLE II - ADDRESS
