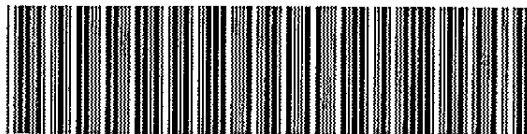

ARTICLE VII - NATURE OF BUSINESS






