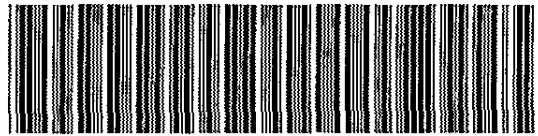

ARTICLES OF INCORPORATION

OF

4973POPPA, INC.

ARTICLE I - NAME

The name of this corporation is 4973POPPA, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE
