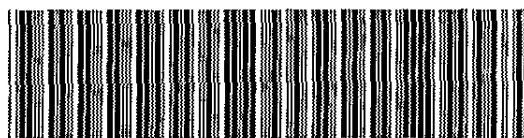

**ARTICLE I. NAME**

**ARTICLE II. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on October 30, 2006.

**ARTICLE III. PURPOSE**

This corporation may engage in any activity or business permitted under the laws of the United States and Florida to the extent permissible under the laws and rules of the State of Florida. *The specific nature of business is REALTOR*

**ARTICLE IV. AUTHORIZED SHARES**
