The undersigned incorporator, LE ROGERS, an individual authorized to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is SHORELINE CONSTRUCTION OF NW FLORIDA, INC.

ARTICLE II - PRINCIPAL OFFICE

The initial address of the principal office of the corporation is 131 Shoreline Drive, Gulf Breeze, Florida 32561,

<u> ARTICLE III - PURPOSE</u>

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.
