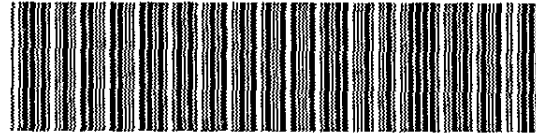

ARTICLE I NAME

The name of the corporation shall be:

The purpose for which the corporation is organized is:

- a) To engage in the business of providing consulting services in the areas of insurance, finance, credit, investment, and any other type of consulting services to companies, institutions, and individuals.
- b) To carry on its operations and conduct business in any State, District of Columbia, and in any territory, dependency or possession of the United States and in any foreign Country.
- c) To do every other act or thing incidental or appurtenant to or growing out of or connected with said business or powers of any part thereof.

- e) To purchase, lease or otherwise acquire, hold, develop, improve, mortgage, sell exchange, let or in any manner encumber or dispose of real property wheresoever situated.
- f) To purchase, lease or otherwise acquire all or any part of the property, rights, businesses, contracts, goodwill, franchise and assets of every kind, of any corporation, co partnership, association or individual (including the estate of a decedent) carrying on or having carried on in whole or in part any of the aforesaid business or any other businesses that the Corporation may be authorized to carry on and to undertake, guarantee, assume and pay the indebtedness and liabilities thereof and to apply for any such property rights,

business contracts, goodwill, franchises or assets by the issue in accordance with the laws of Maryland, of stocks, bonds or other securities of the Corporation or otherwise.

g) To apply for, obtain, purchase or otherwise acquire any patents, copyrights, licenses, trademarks, trade names, rights, processes, formulas and the like, which might be used for any of the purposes of the Corporation and to use, exercise, develop, grant licenses in respect of, sell and otherwise turn to account the same.

h) To loan or advance money with or without a security without limit as to amount and to borrow or raise money for any of the purposes of the Corporation and to issue bonds, debentures, notes or other obligations of the Corporation of any nature, and in any manner permitted by law, for money so borrowed or in payment for the property purchase, or for any other lawful consideration and to secure the payment thereof and of the interest thereon by mortgage, upon or pledge or conveyance of assignment in trust for the whole or any part of the property of the Corporation, real or person, including contract rights, whether at the time owned or thereafter acquired, and to sell, pledge, discount or otherwise dispose of such bonds, notes or other obligations of the Corporation for its corporate purposes.
