

ARTICLES OF INCORPORATION

OF

RUSSELLA CONSULTING, INC.

ARTICLE I

NAME

The name of this corporation is RUSSELLA CONSULTING, INC.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

AMENDMENTS

At the shareholders' meeting, the affirmative vote of the holders of a majority of shares entitled to vote shall be required for adoption of the proposed amendment.
