ARTICLES OF INCORPORATION OF

Joey Hendricks Stump Grinding, Inc.

The undersigned incorporator to these Articles of Incorporation hereby form a corporation under the laws of the State of Florida as follows:

ARTICLE I

Joey Hendricks Stump Grinding, Inc.

The name of this Corporation is Joey Hendricks Stump Grinding, Inc. The address of the Corporation is: 11635 Chesterfield Dr. Dade City, Florida 33525.

ARTICLE II

Term of Existence

This Corporation shall have perpetual existence, Beginning January 1, 2007 with the Florida Secretary of State.

- (h) To make contracts and guaranties and incur liabilities, borrow money at such rates of interest as the Corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.

- (i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
