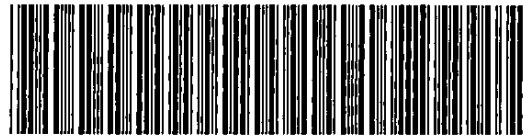



business related to transacting any or all lawful business.


