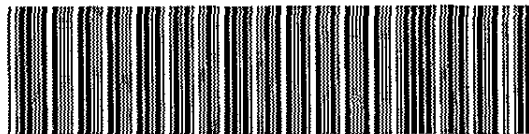

ARTICLE I

**NAME**

The name of the corporation is Designer Doorware, Inc.. The principal office address and the mailing address of said Corporation is 14286-19 Beach Boulevard #227 Jacksonville, Florida 32250.

ARTICLE II

**DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the department of state.

ARTICLE III

**PURPOSE**

### **INDEMNIFICATION**

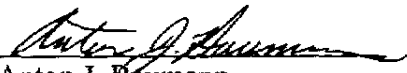

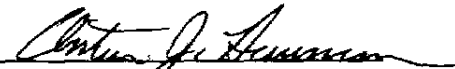
