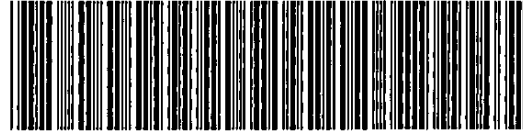

Article IV


The Corporation may issue 100(One Hundred) of Voting Common Stock of Par value \$ 1.00 each Share with preemptive Rights preserved
