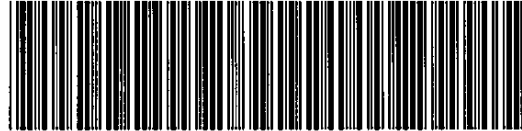



The name of this corporation is A/C SOLUTIONS OF NORTH FLORIDA, INC.





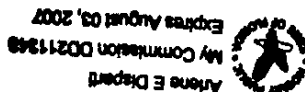
