# ARTICLES OF INCORPORATION

# OUTSOURCING SERVICES, CORP.

The undersigned in order to form a Corporation for the purposes hereinafter stated, by and under the provisions of Statutes of the State of Florida, does hereby subscribe to these Articles of Incorporation.

## ARTICLE I - NAME

The name of this Corporation is: OUTSOURCING SERVICES, CORP.

# ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing on the date of execution of these Articles of Incorporation.

### ARTICLE III - PURPOSES

This Corporation is organized for the following purposes:

- a: To purchase, receive, lease, or otherwise, own, hold, improve, use and otherwise deal with real or personal property or any legal or equitable interest in property wherever located; to sell, convey, mortgage, pledge, create a security interest in, lease, exchange, and otherwise dispose of all or any part of its property.
- b. In the purchase or acquisition of property, business rights or franchises, or for additional working capital, or for any other objective in or about its business affairs and without limit as to amount: to incur debts and to arise, borrow and secure the payment of

money in any lawful manner. The Corporation may issue its stock for any lawful purposes, including the acquisition of any other entity.

c. To engage in any or all lawful activity and to institute and promote commercial, mercantile, financial and industrial enterprises, and for the purposes of transacting any or all lawful business.

#### **ARTICLE IV - POWERS**

This Corporation shall have all of the corporate powers cnumerated in the Florida Business Corporation Act.

### ARTICLE V - CAPITAL STOCK
