

ARTICLES OF INCORPORATION FOR

TRUE VALUE APPRAISAL OF THE FLORIDA SUNCOAST, INC.

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- I. NAME. The name of the corporation shall be TRUE VALUE APPRAISAL OF THE FLORIDA SUNCOAST, INC.
- II. TERM. This corporation shall exist perpetually.
