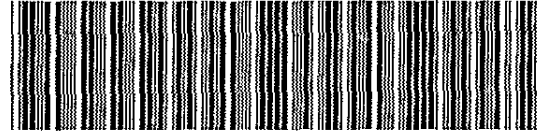

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation for profit under Chapter 621 of the Florida Statutes

ARTICLE I - NAME

The name of the Corporation shall be:

STATURE APPAREL, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office will be at 724 Burlwood Street, Brandon, Florida 33511, and the mailing address is Post Office Box 2302, Tampa, Florida 33601.

ARTICLE III - PURPOSE

The Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state or country, territory or nation.

ARTICLE IV - SHARES

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is \$1,000 shares of common stock having a par value of \$1.00 per share.
