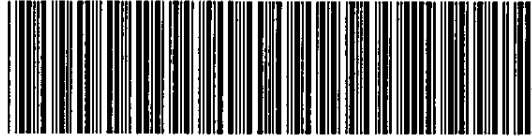

**The ARTICLES OF INCORPORATION of McFATTER FENCE, INC., are  
as follows:**

**ARTICLE I.**

**The name of this corporation shall be McFATTER FENCE, INC.**

**ARTICLE II.**

**The duration of this corporation is perpetual.**

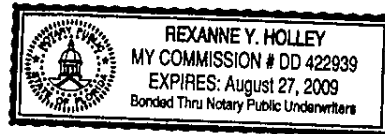

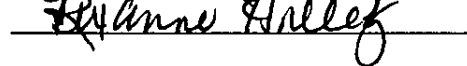
