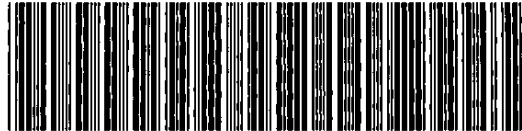

The undersigned, acting as incorporator of J.R. Paul Properties, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

J.R. Paul Properties, Inc.

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE III. PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV. PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of the corporation is 2020 Dundee Road, Post Office Box 898, Winter Haven, FL 33884-1103.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to issue is 10,000 shares of common stock. Such shares shall have a par value of \$.10. The consideration to be paid for each share shall be fixed by the board of directors and may be paid in whole or in part in cash or other property, tangible or intangible, with a value, in the judgment of the directors, equivalent to or greater than the full par value of the shares. The common

stock has unlimited voting rights and is entitled to receive the net assets of the corporation upon dissolution.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the corporation's initial registered office is 2020 Dundee Road, Winter Haven, FL 33884-1103, and the name of the corporation's initial registered agent at that office is Eugene S. Paul.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The corporation shall have three (3) directors initially. The number of directors may be increased or diminished from time to time, as provided in the bylaws, but shall never be less than one (1). The name and street address of the initial directors are:

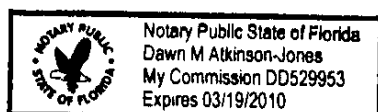
