ARTICLES OF INCORPORATION OF J.R. PAUL PROPERTIES, INC.

The undersigned, acting as incorporator of J.R. Paul Properties, Inc., under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME


