This corporation shall have the broad general powers set forth in Chapter 607.0302, Florida Statutes.

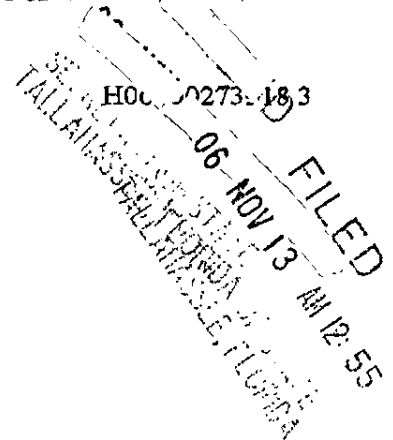
3. **Authorized Shares.** The corporation shall have the authority to issue One Thousand (1,000) shares of common stock. The par value of the stock is \$1.00.




